Furthermore, the students need to acquire an efficient understanding. In addition, one needs to ensure, they put these into operation in a well-ordered manner. As a consequence, students will render an important contribution in achieving educational goals and leading to up-gradation of overall system of education. Therefore, leading to up-gradation of overall system of education is a useful measure to be implemented in leading to up-gradation of all levels of education.

### V. CONCLUSION

Education prepares individuals to promote enhancement of their overall living conditions. Measures to be implemented in leading to up-gradation of all levels of education are, formulation of laws and rules, development of mutual understanding, leading to up-gradation of teaching-learning methods, promoting enhancement of instructional strategies, leading to up-gradation of teaching-learning materials, utilizing pioneering methods and materials, organizing seminars and workshops, imparting information regarding extra-curricular and creative activities, augmenting skills and abilities, managing resources, providing infrastructure, amenities and facilities and leading to up-gradation of overall system of education.
